THE ACADEMY AND ITS OBJECTIVES

The Academy of the Social Sciences in Australia (prior to July 1971 the Social Science Research Council of Australia) is a corporate body of social scientists. Its functions are:

- (i) to encourage the advancement of the social sciences in Australia;
- (ii) to act as a co-ordinating group for the promotion of research and teaching in the social sciences;
- (iii) to foster research and to subsidise the publication of studies in the social sciences;
- (iv) to encourage and assist in the formation of other national associations or institutions for the promotion of the social sciences or any branch of them;
- (v) to act as the Australian national member of international organizations connected with social sciences; and
- (vi) to act as a consultant and adviser in regard to social sciences.

For the origins and development of the Academy, see the 1975-76 (or an earlier) *Annual Report*, and K.S. Cunningham: *The Social Science Research Council of Australia 1942-1952*, SSRC, Canberra, 1967.

Each member, on election to the Academy, takes the title of Fellow. As at 30 June 1985 there were 195 Fellows of the Academy. New Fellows are elected by postal ballot on the recommendation of the Membership Committee. The Academy's functions are discharged by an Annual General Meeting and the Executive Committee. The Executive Committee consists of the President, the Treasurer and seven other members all elected at the Annual General Meeting.

Since 1953 the Australian Government has provided an annual grant to assist the Academy to meet administrative and travel costs. In 1984-85 the grant was \$84,575.

Four Panels, each representing related groups of disciplines as described on page 7 above, serve the Academy with advice relating to membership matters, the selection of new research topics and general policy issues. Panel activities are supplemented by assemblies of Fellows on a State basis which meet from time to time in the various capital cities to discuss issues of current significance to particular States or other matters referred to them by the Executive.

The Academy has put much emphasis upon its *Major Research Projects*, which are described in the next section of this *Report*. They have stimulated new

research, both among the Fellows of the Academy and throughout universities and research institutes in Australia. They have also helped to clarify issues of national significance and have at times involved close collaboration with government officials and departments at both Federal and State levels. This interaction has been essential to the progress of these Projects, particularly in the cases of the Projects on the *Aborigines in Australian Society* and *Immigrants in Australia*.

In 1984-85 the Academy began work in a new area, *Health and Behaviour*, with an initial workshop to explore the potential of this topic as a theme for a further major project. Another area under exploration in 1984-85 was Australia's relationship with the South Pacific Islands. Further details of these new developments follow in the next section of this *Report*.

The Academy also pursues a number of shorter-term enterprises which aim to study topics assessed to be of major significance, both academically and nationally. These form the basis of the Academy's annual programme of seminars and workshops, which have been playing an increasingly important role over the past three or four years. Further details also follow in the next section of this *Report*.

Research is not, however, the only function of the Academy: it also has a role to play as a consultant and adviser and in promoting and encouraging 'the advancement of the social sciences' both in Australia and abroad. In these wider roles the Academy appreciates its collaboration with the Academies of Science, the Technological Sciences and the Humanities through the deliberations of the Consultative Committee of the Australian Academies and in joint seminars and workshops. It also seeks a more effective liaison with government departments and research organizations which are prime users of social science concepts, data and methodologies.

The Academy sustains its international activities through its affiliation with the Association of Asian Social Science Research Councils (AASSREC) but unfortunately had to withdraw from its affiliation with the International Federation of Social Science Organizations (IFSSO) because of financial stringencies. A new venture of considerable significance initiated in 1980 was continued: an interchange scheme between the Australian Academies of the Social Sciences and the Humanities, acting jointly, and the Chinese Academy of the Social Sciences (see page 12 below). The Academy expresses its appreciation of the Australian Government's continued support for this scheme.

ACADEMY ACTIVITIES

1. RESEARCH

Four *Major Projects* have been completed by the Academy and its predecessor, the Social Science Research Council of Australia: *Women in Australia*, *Taxation in Australia*, *Aborigines in Australian Society* and *Immigrants in Australia*. Explorations for further projects continue in two areas: *Australia and the South-West Pacific*, and *Health and Behaviour*.

The results of each of the first two projects were produced as a single volume. The *Aborigines* Project was a much larger and longer-term enterprise which generated twelve research monographs and three major synoptic volumes by the Project's Director, Dr Charles Rowley. This series covers a wide range of topics including the history of Aborigines since European settlement in Australia, their settlement patterns in both remote and urban areas, their economic status, their health and their morbidity. In 1984-85 Dr Rowley continued studies of Aboriginal communities.

In the *Immigration* Project, ten monographs were published. These include studies of selected ethnic groups, immigrant communities, patterns of income and expenditure, political attitudes and behaviour, and the impacts of professional and highly skilled immigrants in Australian society. This project did much to stimulate research of ethnic communities in Australia and in other issues of vital concern to immigrants such as the series *Studies in the Education of Migrant Children*, which was financially supported by the Commonwealth Department of Education. Under the title *The Educational Experience of Sydney High School Children*, the first Report was produced in 1979, the second in 1981, and the third in 1983.

As the year opened, two Workshops were being planned. The first concerned the preparation of a major seminar to be held early in 1986 in association with the Research School of Pacific Studies, Australian National University on the topic of *Australia and the South-West Pacific*. The other, an initial study of *Health and Behaviour*, progressed to the stage of a Workshop held in May 1985. The results of this Workshop will be analysed by the Project Committee with a view to considering what further activity might be taken in this area of study in subsequent years.

The Academy also continued its sponsorship of 'Trend Reports'. The three-volume *Surveys of Australian Economics* was followed by the publication of the second 'Trend Report', *Surveys of Australian Political Science* under the guidance of an Editorial Committee with Professor D. Aitkin as Chairman. This volume covers the development and situation of political science, political theory, political history and biography, political institutions, electoral systems, international relations and radical political science. The *Psychology* volume, edited by Professor N.T. Feather, entitled *Australian Psychology: Review of Research* has been completed, while work continues on other Reports in

Geography, Education, Law and Social Anthropology Other studies are being planned for *Sociology, Demography and Linguistics*. The series is being published by George Allen and Unwin Australia Pty Ltd.

2. ANNUAL SYMPOSIA

The Academy continued its review and discussion of topics which were felt to be of national interest. The *Annual Symposium* held at the Annual General Meeting in November 1984 was on the topic *Social Democratic Governments in Action: Aspiration and Achievement*. Papers presented were:

- *Better our Dreams than their Nightmares: Democratic Socialism in Practice* (Mr Peter Duncan)
- *Democratic Socialism as a Political Philosophy* (Dr P.N. Pettit)
- *Social Democratic Economics Once Again* (Dr B. Hughes)
- *Social Democratic Governments: The Failure of Economic Controls* (Professor M.G. Porter)
- *The Short History of Social Democracy in Australia* (Dr S.F. Macintyre)
- *Women as Voters: 'big brother scolds us . . .'* (Dr Carol Bacchi)

It is hoped that the *Proceedings* of the Symposium will be published.

In November 1984 the Annual General Meeting agreed that the Annual Symposium for November 1985 should discuss the topic *Equality of Opportunity Reconsidered*.

3. ANNUAL LECTURE

The Twelfth Annual Lecture of the Academy was given in the Coombs Lecture Theatre, Australian National University on Tuesday, 6 November 1984 by Mr H.H. Stretton, Reader in History, The University of Adelaide. The Lecture entitled *Tasks for Social Democratic Intellectuals* is expected to be published as an integral part of the *Proceedings* of the 1984 Academy Symposium.

The Academy Lecturer chosen for 1985 is Professor Peter Karmel, Vice-Chancellor, Australian National University. His topic *Quality and Equality in Education* has been chosen to complement the 1985 Symposium referred to above.

4. INTERNATIONAL ACTIVITIES

The Academy continued its affiliation with the Association of Asian Social Science Research Councils (AASSREC) and was Vice-President in 1984-85.

In 1984-85 the fourth round of the *Exchange Scheme* between the Chinese Academy of Social Sciences and the Academies of the Humanities and of the

Social Sciences in Australia was completed. A delegation consisting of the Presidents and Executive Officers of the Australian Academies visited China as the guest of the Chinese Academy of Social Sciences in August 1984. The delegation held discussions with the Chinese Academy in Peking and visited Provincial Academies in Xian, Shanghai and Guangzhou. Visits were also made to Fudan University in Shanghai and the Sun Yat Sen University in Guangzhou.

(a) *Chinese-Australian Exchange Scheme*

The delegation held discussions with the Commonwealth Department of Home Affairs and the Environment, CSIRO, Western Australian Department of Conservation and Environment, Western Australian Department of Agriculture, ALCOA and universities in Sydney, Canberra, Melbourne and Perth.

(b) AASSREC

As Vice-President of AASSREC 1984-85, the Academy was represented by the Executive Director at the Executive Meeting held in Bangkok in September 1984 where the main Agenda item was the preparation of the programme for the Sixth Biennial Conference to be held in Indonesia in September 1985.

As President of the Fifth Biennial Conference held in Sydney in December 1983, ASSA was responsible for the publication of the Proceedings of this meeting. The Proceedings are being published in three parts:

1. *Asian Social Scientist: Newsletter No. 5*. The formal Proceedings;
2. *The Economic Future of the Asian Region and the Role of the Social Sciences*. Proceedings of a Panel Discussion, edited by Professor R. Gates; and
3. *Asian Perspectives in Social Science*. Proceedings of a Symposium, edited by Professor W.R. Geddes, and being published by the Seoul National University Press.

(c) IFSSO

Because of lack of funds, the Academy reluctantly had to terminate its membership of the International Federation of Social Science Organizations.

5. JOINT ACADEMY ACTIVITIES

Two meetings of the Consultative Committee of the Australian Academies were held in October and April. ASSA's term as Chairman ended in October 1984. The Consultative Committee continued to consider matters including the funding of research, the funding of representation of national disciplinary bodies in international organizations, and the recognition of each of the four Academies as the national representative for the scholarly disciplines within their respective memberships.

The Committee continued its project on *The Protection of Prehistoric Places*. ASSA's contribution, the study of the effects of tourism on selected sites (Kakadu National Park and Uluru) by Professor Fay Gale, was completed. ASSA also supported a proposal to the Minister of Aboriginal Affairs that a national research and preservation unit should be established to be incorporated eventually in the Australian Museum.

6. TAX EXEMPTION STATUS

During the year a further approach was made to the Prime Minister seeking exemption from income tax for gifts to the Academies under Section 78(1) (a) of the *Income Tax Assessment Act*. Without this privilege the Academy has been severely handicapped in efforts to raise funds for purposes other than research, for example for general administrative expenses, staff supplementation and accommodation costs.

The Academy was delighted when the request was granted and the appropriate Amendment incorporated in the Income Tax Assessment Act.

7. NEWSLETTER

The *Newsletter*, which was first published in May 1982, continues to be published bi-annually. The current editor is Dr J.J. Smolicz of the University of Adelaide.

8. ADMINISTRATION

Professor W.D. Borrie, who has been Executive Director of ASSA since 1979, will be retiring from the position at the close of the financial year. Professor R.G. Neale has been appointed to the position, and will take up his appointment on 1 July. The Academy continues to occupy offices in the Garden Wing, University House, Australian National University.

Publications Arising from Sponsored Activities and Direct Subsidy

Until 1977 the Academy assisted a number of activities by contributing to the cost of seminars, providing travel grants for study in Asia, or by directly subsidising journals. Many publications arose from these activities and lists of such are printed in the *Annual Report* for 1976-77 and earlier under the headings *Publications Arising from Sponsored Activities* and *Publications Subsidised by the Academy*.

The policy of sponsorship and subsidy was discontinued in 1977.

FELLOWS OF THE ACADEMY

The *Rules* of the Academy state that 'persons who are deemed to have achieved distinction in one or more branches of the social sciences may be elected as Fellows of the Academy if (i) they are nominated by one Fellow and seconded by two other Fellows; (ii) they are recommended by the Membership Committee after investigation of their eligibility; and (iii) they receive the support of a majority of the Fellows for the time being at a postal ballot'.
