2023 AGM RESOLUTIONS

7	<p>Appointment of External Auditor</p> <p>The Office of Regulatory Services requires the Academy’s Financial Statements to be audited by a registered company auditor. To meet this requirement, the Executive Committee recommends the re-appointment of Anthony Wilson of AccountAbility (ACT) Pty Ltd for the 2023-24 financial year.</p>
8	<p>Confirmation of 2024-25 Membership Fees</p> <p>Background</p> <p>At the 2022 AGM, members approved a change in the structure of membership fees to bring the Academy in line with other learned Academies, to improve equity across the Fellowship and to support the costs of running the organisation.</p> <p>A new fee category with a 30% discount was introduced for Fellows working part-time (<20 hours per week) and it was agreed that the full fee rate would increase by \$50 p.a. (approx.) for three years.</p> <p>Resolution</p> <p>It is proposed that membership fees for 2024-25 will be set at:</p> <ul style="list-style-type: none"> • Full-time Ordinary Fellows – \$650 (inc. GST; 2023-24 rate \$600) • Part-time Ordinary Fellows – \$455 (inc. GST; 2023-24 rate \$420) • Retired/Overseas Fellows – \$325 (inc. GST; 2023-24 rate: \$300) • Honorary Fellows – no fee • Emeritus Fellows (opt in from age 80) – no fee.
9	<p>Special resolution to transition to a company structure and to adopt a new constitution</p> <p>Background</p> <p>The Academy is an Incorporated Association under the <i>Associations Incorporation Act 1991 (ACT)</i> (this incorporation dating from 1957 and the establishment of the Social Science Research Council of Australia Inc.)</p> <p>With a growing and national scope of operations, including several interstate staff and coordination of significant events and activities outside the ACT, this entity structure is no longer fit-for-purpose, and the Executive Committee wish to migrate the structure to that of a Company Limited by Guarantee.</p> <p>The <i>Corporations Act 2001</i> provides for such a migration without affecting the continuity of the entity or its charitable or DGR status. The primary impacts would be the adoption of a new company constitution and a transfer from regulation under the Associations Act to ASIC (although still under the umbrella of the Australian Charities and Not-For-Profits Commission).</p> <p>The proposed company constitution has been circulated to members with the AGM papers. It is based on the ACNC template constitution for not-for-profit companies limited by guarantee with inclusion of the Academy’s objects and specific requirements pertaining to membership and the process for election as a</p>

	<p>Fellow. Two standard clauses of the template constitution have been removed: the first making provision for member representatives, and a second for member's to convene a general meeting in cases where directors fail to do so on receipt of a proper request.</p> <p>Importantly, the proposed constitution omits procedures for appointment of the President and Officers, as well as procedures for Executive and other committee meetings. Following modern practice, these matters will be incorporated into by-laws that can be more easily be updated as needs arise.</p> <p>Special Resolutions</p> <p>In order to proceed with the migration, the Executive Committee proposes the following special resolutions.</p> <ul style="list-style-type: none"> a) That the Academy migrate from an Incorporated Association to a Not-For-Profit Company Limited by Guarantee b) That in making this migration, the Academy adopt the proposed company constitution as circulated to members.
<p>10</p>	<p>Election of President Elect</p> <p>The Academy President serves a three-year term, preceded by one year as President-Elect and followed by two years as Immediate Past President. The term of the current President concludes on 31 December 2023.</p> <p>As advised in a notice to all Fellows on 24 October, 2023, the Academy's Executive Committee's has nominated Professor Kate Darian-Smith for the role of President-Elect. No other nominations have been received. Therefore, it is proposed that Kate Darian-Smith is elected President Elect of the Academy commencing January, 2024.</p>
