5. President's Report

The Chair moved that the President's Report as published in the 2022 Annual Report be accepted.

6. Treasurer's Report

The Chair introduced the Treasurer, Professor Wai Fong Chua, and thanked her for her work.

The Treasurer gave a verbal report introducing the Audited Financial Statement. Noting:

- The Academy is in a strong financial position, with net assets of \$1.65 million and secure revenue from Government block grant and membership fees.
- The full year result was a statutory surplus of \$233,027.
- However, this result is somewhat skewed by the need to recognise receipt of a \$300,000 donation that was received during the year.
- This donation was made to allow the Academy to establish the Rechnitz Fund, to be allocated
 in grants over the coming decade and the expenditure will be recognised in the accounts
 during those years.
- To give a more balanced picture of the Academy's performance over the financial year, if the \$300,000 is set aside, there is an effective deficit of \$66,973.
- This deficit in turn consists of an operating surplus of \$15,854 which was in line with budget, and an investment of \$82,827 from the Academy's Strategic Initiatives Fund in the Seriously Social podcast and communications platform, and the State of the Social Sciences report.

The Treasurer referred Fellows to the Audited Financial Statements published in the 2022 Annual Report.

7. Appointment of External Auditor

The Office of Regulatory Services requires the Academy's Financial Statements to be audited by a registered company auditor. To meet this requirement, the Executive Committee recommends the reappointment of Anthony Wilson of AccountAbility (ACT) Pty Ltd for the 2022/23 financial year.

The Treasurer moved that the current auditor, Anthony Wilson of AccountAbility (ACT) Pty Ltd, be reappointed for the 2022/23 financial year.

8. Confirmation of 2023-24 Fellowship Fees

The Academy's Executive Committee has undertaken a review of membership fees in comparison with Australia's other learned Academies with a view to ensuring equity across the Fellowship and supporting the costs of running the organisation. This review has identified that membership fees for the Academy of the Social Sciences in Australia are lower than those of each of the other four Learned Academies, and also that we lack a discounted rate for Fellows employed on a part-time basis.

Accordingly, it is proposed that:

- membership fees for Fellows employed on a full-time basis be increased by \$50 p.a. (approx.). for three years
- that a 30% discount on fees be introduced for Fellows employed on a part-time basis (<20 hours per week)
- that the existing 50% discount be retained for retired Fellows and those living overseas.

This change would place the Academy's fees at the lower end of other Australian Academies, while addressing equity considerations that have been raised by some Fellows about the current arrangements where part-time or semi-retired Fellows pay full fees.

With approval of this motion, membership rates for 2023-24 would be:

- Full-time Ordinary Fellows \$600 (inc. GST; 2022-23 rate \$552)
- Part-time Ordinary Fellows \$420 (inc. GST; 2022-23 rate \$552)
- Retired/Overseas Fellows \$300 (inc. GST; 2022-23 rate: \$275)
- Honorary Fellows no fee
- Emeritus Fellows (opt in from age 80) no fee.

9. CEO's Report

The CEO, Dr Chris Hatherly, spoke to his report as published in the 2022 Annual Report, noting highlights of the reporting period of the 2021-22 financial year including:

- The Academy's 50th anniversary since it was established as an Academy in 1971, with a longer period preceding that as the Council for Social Sciences.
- The 2021 Annual Symposium held online due to Covid19, titled The Social Future of Australia.
- The 2022 Annual Symposium to be held in Melbourne at the end of November, titled Democracy: Risk, Relevance, Revival, based on the challenge of the democratic deficit as identified in the State of the Social Sciences Report.
- The transition of Academy presidency from former President Jane Hall to current President Richard Holden.
- The conclusion of the 2019-22 Strategic Plan and the introduction of the 2023-25 Plan.
- The introduction of new IT and finance systems within the Academy's National Office to streamline administration processes.

The CEO moved that the CEO's Report as published in the 2022 Annual Report be accepted.

10. Announcement of the Rechnitz Fund for Indigenous Society, Language and Culture

The Chair formally announced a new initiative of the Academy that has been made possible by a generous donation from the estate of Dr Wilhelm Rechnitz, and provided a brief background:

- Dr Rechnitz was born in Germany in 1899 and trained in the classics before fleeing Nazi Germany for the UK in 1933. At the start of the war he was detained as an enemy alien and transported to Australiaon the HMT Dunera in 1940.
- After his release from wartime internment, he lived and taught at schools in Melbourne and NSW, before becoming ordained as a priest of the Church of England.
- His work took him to the Torres Strait Islands in the late 1940s, and he developed a life-long interest in the Island peoples and the culture. Over almost 20 years living and working with Torres Strait Island communities between 1948 and 1972 he learned and documented the languages and culture, including a substantial written and photographic record now held by the State Library of Qld.

• Wilhelm Rechnitz died in Brisbane in 1979. His estate is overseen by his close friend Mr Ralph O'Brien, who was present online for the meeting.

The Chair advised this generous gift will allow the Academy to establish the Rechnitz Fund to provide research grants to Aboriginal and Torres Strait Islander social scientists in the early- and middle-stages of their research careers, and to recognise research excellence and leadership in research on Indigenous knowledge and culture through an annual Rechnitz Award. Grant applications and award nominations will open early next year and close at the end of April; annually thereafter.

The Chair thanked Ralph O'Brien once again, and acknowledged the Academy's former President Leon Mann whose introduction of Ralph to the Academy and contribution to the planning were instrumental in helping get to this point.

11. Highlights

Policy

Chair of the Policy Committee, Professor Kevin McConkey, thanked the committee, the policy team at the National Office and the Fellows who contribute to the Committee's work, and spoke on:

- The development of a new process to anticipate upcoming potential policy initiatives in the form of a rolling 12 month policy work plan.
- The ongoing work on social science research infrastructure and reporting on national and international trends.
- The ongoing work on the Australian Research Council (ARC) and Excellence in Research for Australia (ERA) review.
- The ongoing work on the Australian Universities Accord.

Grants and Awards Committee

Chair of Grants and Awards Committee, Professor Neal Ashkanasy, acknowledged his predecessor Cindy Gallois, and spoke on:

- The four Paul Bourke Award winners for 2022, Dr Sophie Webber, Dr Felix Septianto, Dr Gemma Sharp and Dr Harry Hobbs.
- Work to review and improve the application and assessment process for the Paul Bourke Award.
- 16 applications received for the Workshop Program, with 8 of the Workshops being granted for 2023.

International Program

Chair of the International Committee and International Secretary, Professor Fleur Johns, thanked spoke on the work of the international program at the Academy:

- Both the ASSA-CASS Joint Action Program and the Australia-France Collaborative Research Program have been renewed and extended.
- The Academy remains involved in the International Science Council (ISC) and has supported Fellows to be involved in various ISC Committee's.
- The Academy continues to play an active role as Secretary General of the Association of Asian Social Science Research Councils (AASSREC). The AASSREC 25th biennial conference is to be held in Korea in June 2023.
- Through AASSREC, the Academy is involved in two exciting projects; the design and implementation of a journal directory and a mentoring program to support junior social science researchers in the region.

 The Academy also has ongoing involvement and collaboration with colleagues from the Royal Society Te Apārangi.

Communications and RAP

The CEO spoke on the Communication Strategy and Reconciliation Action Plan (RAP), noting:

- The 50th episode of the Seriously Social Podcast, hosted by experienced radio journalist Ginger Gorman had recently been released.
- The new school engagement program in partnership with the Museum of Australian Democracy is progressing, with the production of learning resources linked to the curriculum. The schools initiative will be a strategic priority going forward.
- There has been significant work on the Reflect RAP with progress or completion of most of the
 53 targeted actions. The next Innovate RAP is in the early stages of development.

The Chair thanked the Committee Chairs and representatives for their reports and the AGM **noted** the reports.

12. 2023-25 Strategic Plan

The Chair introduced the 2023-25 Strategic Plan, which is a revised edition of the Academy's plan endorsed in late-2019. The major changes include the following:

- A re-arrangement of the focus areas: policy and advocacy promoted to the 'first' column, and reconciliation integrated across all activities rather than singled out as a discrete area of work.
- A new focus on school education, with a decision by the Executive to invest part of our strategic initiative reserve in a new program to create and promote curriculum-linked teaching and learning resources for high school students and teachers.
- The resources will bring Fellow-reviewed social science content into the classroom, and will link to the Academy's successful Seriously Social podcast as well as the growing Social Sciences Week program, and a new initiative promoting social science study and career pathways that the Academy is commencing in partnership with disciplinary societies and associations.
- The establishment of a new Education Committee of the Executive to oversee the abovementioned work.
