	he Office of Regulatory Services requires the Academy's Financial Statements to e audited by a registered company auditor. To meet this requirement, the executive Committee recommends the re-appointment of Anthony Wilson of ccountAbility (ACT) Pty Ltd for the 2024-25 financial year.		
8	Confirmation of 2025-26 Membership Fees		
	Background		
	At the 2022 AGM, members approved a change in the structure of membership fees to bring the Academy in line with other learned Academies, to improve equity across the Fellowship and to support the costs of running the organisation.		
	A new fee category with a 30% discount was introduced for Fellows working part-time (<20 hours per week) and it was agreed that the full fee rate would increase by \$50 p.a. (approx.) for three years.		
	Resolution		
	It is proposed that membership fees for 2024-25 will be set at:		
	 Full-time Ordinary Fellows – \$700 (inc. GST; 2024-25 rate \$650) Part-time Ordinary Fellows – \$490 (inc. GST; 2024-25 rate \$455) Retired/Overseas Fellows – \$350 (inc. GST; 2024-25 rate: \$325) Honorary Fellows – no fee Fellows Emeriti (opt in from age 80) – no fee.
